The Principals of Government Polytechnics are invited to the subject and reference cited, wherein the Principals/CDTP Co-Ordinators were requested to take action on the following points.

**I. UPGRADATION OF EXISTING POLYTECHNICS:**

1. Expediting of Expenditure
2. Submission of Consolidated UC, SOA, PPR and Bank interest statement audited by auditor In prescribed format up to the F.Y. 2016-17 i.e. up to 31.03.2017

**II. COMMUNITY DEVELOPMENT THROUGH POLYTECHNICS(CDTP):**

3. Expediting of Expenditure
4. Submission of UC, SOA & PAR audited by auditor In prescribed format as given in the **CDTP Guide lines Book** up to the F.Y. 2016-17 i.e. up to 31.03.2017
5. Submission of Operational plans to NITTTR, Chennai every year in the month of April
6. Submission of Quarterly Reports every year regularly i.e. for I-Quarter after June  
II-quarter after September  
III-quarter after December and  
IV-quarter after March along with yearly Physical Achievement Report
