In continuation of this office memo vide reference 1<sup>st</sup> cited, it is informed that, the Chairman, Telangana Brahmin Samkshema Parishad have observed that there is not much response from the students to avail cash wards under **Saraswathi Vidya Prasasthi Scheme** due to limiting it to one student per institution. Therefore, it is now decided to make eligible **all the students of Brahmin Community** who secure more than the cut off marks as shown below:

| 5. Professional Education     | - | 80 percent and above |

In view of the above, to avail the benefit under the above scheme by the Brahmin Students have to submit a Bona fide Certificate from the institution in which he/ she has joined. The formats of the two certificates are enclosed in the earlier memo, vide reference 2<sup>nd</sup> cited.

In this regard, as per the Government Memo cited above, all the Principals of the Government / Aided / Private un-Aided / 2<sup>nd</sup> shift Polytechnics in existing Engineering colleges are here by instructed to issue certificates to **all the eligible students of Brahmin Community** in the prescribed formats, to enable them avail the benefits under the scheme.



*Dear Madam,*

As you are aware, Government have constituted Telangana Brahmin Samkshema Parishad vide G.O.Rt.No.267, General Administration (Cabinet) Department, dated. 28.1.2017, with a view to extend a helping hand to the needy Brahmin community in the State, especially the Brahmin youth, in matters of education, healthcare, training in skills development, welfare, entrepreneurial programmes, etc.

- Accordingly, Telangana Brahmin Samkshema Parishad has taken up an initiative in launching of **SARASWATI VIDYA PRASASTHI SCHEME**, under which a Brahmin student studying in SSC/Diploma/Degree/PG/ Professional course and is a **Topper** from that School/College/Institution in Telangana State will be given certain cash reward to encourage him/her pursue higher education. The details of category-wise marks and the amount of cash rewards under the scheme are enclosed.

- In order to avail the benefit under the above scheme by **Topper Brahmin Student**, we have made it mandatory that a **Certificate** from the educational institution concerned is to be submitted to the effect of being a topper among the Brahmin students; and also a **Bona fide Certificate** from a higher institution in which he/she has joined. The formats of these two certificates are enclosed.

I, therefore, request you to kindly arrange to issue suitable instructions to all the Heads of the Departments concerned under your jurisdiction, who will in turn direct the respective District Heads/Institutions (either Government or Recognized Institutions) for issuing Certificates to Topper Brahmin students in the prescribed formats, to enable them avail the benefits under the scheme.
