ORDER:

Government in the orders 2nd read above, has relaxed the ban on transfers imposed vide Ref. 1st read above. Further, the Government in the orders 4th and 5th read above, have issued the guidelines for the transfer of employees working in Collegiate and Technical Education Departments for the year, 2018. Accordingly, the employees working in Technical Education Department have exercised options for transfers by way of online web counselling and based on the entitlement points of the employees concerned, the transfer orders are being given.

2. In the circumstances, Lecturers in Engineering & Non-Engineering and Senior Lecturers in Engineering & Non-Engineering working in Government Polytechnics in the State are hereby transferred as and posted vide reference 6th cited.

3. Subsequently, it has been noticed that certain errors in postings occurred due to technical reasons and certain staff have not applied for counselling/applied but not exercised options.

4. In the above circumstances and in continuation of this office proceedings 7th cited, further orders of posting are hereby ordered as per annexure enclosed.

5. The Principals concerned are requested to relieve / accept the incumbents immediately and submit compliance report in the matter. The individual transferred now shall be deemed to have been relieved from the present place of working immediately on receipt of the transfer orders within 3 days from the date of issue of the transfer orders.

6. The employees who are transferred on request shall not be entitled to any T.A./D.A. and joining time since the transfers are effected at their request.
