In terms of the instructions issued in this office Memos cited under Ref.1&2, the Principals of Government Polytechnics/Institutions have engaged contract Workshop Attendants for the A.Y. 2015-16 and also terminated their services at the end of the A.Y.2015-16.

As the class work in Government Polytechnics/Institutions for the A.Y. 2016-17 is to commenced from Date:09.06.2016 and the issue of renewal of Contract Workshop Attendants for the A.Y. 2016-17 is under active consideration of the Government of Telangana, as part of the preparatory work for re-engaging the services of Contract Workshop Attendants, it is decided to take options of Contract Workshop Attendants for their postings in various Government Polytechnics/Institutions against vacancies of sanctioned posts of Workshop Attendants / Lab Attenders in existing Government Polytechnics, the details of vacancy position which are shown in Annexure attached to this memo.

In the circumstances, the Contract Workshop Attendants, who were terminated their services at the end of the A.Y.2015-16 are informed to approach the Principals of Government Polytechnics/Institutions where they were terminated last in April 2016, for giving/forwarding their options for postings for the A.Y.2016-17, against the vacancies mentioned above.

In this connection, the Principals of Government Polytechnics/Institutions are requested to obtain option forms in the prescribed pro-forma attached herewith from the Contract Workshop Attendants terminated their services at the end of the A.Y.2015-16 only and send the same by a special messenger to this office on or before **Date: 05-07-2016** for placing the same before a Committee of the three Senior Principals, who will examine the said option forms, as per the vacancy position, in terms of the Rules in vogue and the Committee will make suitable recommendations to the undersigned for eventually giving posting orders to the Contract Workshop Attendants, soon after the permission is accorded by the Government for the renewal of the Contract Workshop Attendants for the A.Y.2016-17.
