**ORDER:**

The Director of Technical Education, Telangana State, Hyderabad in his letter 2<sup>nd</sup> read above has submitted that Ms. Sheelam Sai Priya, D/o S. Arjun Kumar, B. Tech (CSE) III Year, while enclosing the NOCs and the syllabus studied, has requested for transfer from Vardhaman College of Engineering, Kacharam, Shamshabad Dist., (Autonomous and Affiliated to JNTUH, Hyderabad) to Lords Institute of Engineering & Technology, Himayath Sagar, Golconda Post, Hyderabad.(Affiliated to JNTU Hyderabad), in 3<sup>rd</sup> year in B. Tech (CSE) Course on Medical Grounds under Management Quota to Management Quota.

2. The Registrar, JNTUH, Hyderabad which is the University that has affiliated Lords Institute of Engineering & Technology has stated that as per the regulations, the candidate has to study the following subjects on her own and if she fails in any of the subjects, those subjects have to be studied to meet the course structure requirement up to Ist Year of **B. Tech CSE of JNTUH R13** Regulations:

Even though the subjects were studied at the earlier Institution / University, she has to study again as per the **JNTUH R13** Regulations to fulfill the requirement of necessary credits. The candidate has to study and pass all theory and lab courses as per the **JNTUH R13** academic regulations and syllabus.

3. Both the Colleges have given NOCs and the proposed transfer is within the 1% ceiling limit.

4. As per G.O.Ms.No.122, Higher Education (EC.2) Department, dated 01-09-2005, Condition 4 (4) reads as follows:

"no transfers can be permitted from one University affiliated private college to another University affiliated private college as all the Universities in the State are not following uniform syllabus and uniform system of examination"

Condition 4 (7) reads as follows:

" The applications received from 1<sup>st</sup> of April of every year till the last date of the month in which examinations are completed at 1<sup>st</sup>/2<sup>nd</sup>/3<sup>rd</sup>/year levels shall only be considered and the DTE shall dispose of all the requests received, before commencement of the 2<sup>nd</sup>/3<sup>rd</sup>/4<sup>th</sup> year as the case may be so that the students seeking transfers will not be put to hardship of falling short of attendance."

The Government, after careful examination of the matter and in relaxation of the conditions in paras 4 (4) and 4(7) of the G.O 1<sup>st</sup> read above, hereby accord permission for transfer of Ms. Sheelam Sai Priya, D/o S. Arjun Kumar, B. Tech (CSE) (provided she is promoted to the 3<sup>rd</sup> Year) from Vardhaman College of Engineering, Kacharam, Shamshabad Dist., (Autonomous and Affiliated to JNTUH, Hyderabad) to Lords Institute of Engineering & Technology, Himayath Sagar, Golconda Post, Hyderabad.(Affiliated to JNTU Hyderabad) in the 3<sup>rd</sup> year in B. Tech (CSE) Course, on Medical Grounds, for the Academic Year, 2016-17, subject to the condition that the Three subjects mentioned in Para 2 above, the student has to study on her own to meet the syllabus course structure requirement upto the Ist year of B.Tech (CSE) of **JNTUH R13** Regulations and the transfer is to the Management Quota of Lords Institute of Engineering & Technology.
