ORDER:

The Director of Technical Education, Telangana State, Hyderabad in his letter 2nd read above has submitted that Mr. C Sai Kiran S/o, Janardhan, B.Tech, CSE, II year has applied for transfer from Marri Laxman Reddy Institute of Technology & Management, Dundigul, Quthbullapur, Hyderabad(Affiliated to JNTUH, Hyderabad) to D.V.R. “ The applications received from 1st of April of every year till the last date of the month in which examinations are completed at 1st/2nd/3rd/year levels shall only be considered and the DTE shall dispose of all the requests received, before commencement of the 2nd/3rd/4th year as the case may be so that the students seeking transfers will not be put to hardship of falling short of attendance.”

The Government, after careful examination of the matter and in relaxation of the conditions in Para 4(7) of G.O 1st read above, hereby accord permission for transfer of Mr. C Sai Kiran S/o, Janardhan, B.Tech, CSE, II year from Marri Laxman Reddy Institute of Technology & Management, Dundigul, Quthbullapur, Hyderabad (Affiliated to JNTUH, Hyderabad) to D.V.R.
