**ORDER:**

The Director of Technical Education, Telangana State, Hyderabad in his letter 2<sup>nd</sup> read above has submitted that Sri. U. Venkateshwarlu F/o Mr. Uppula Bharath, while enclosing the NOCs and the syllabus studied, has requested for transfer of his son Mr. Uppula Bharath from Lovely Professional University, Punjab to Guru Nanak Institutions Technical Campus, Ibrahimpatnam, R.R.Dist., (Affiliated to JNTUH) in the IInd Year of B. Tech (CSE) Course for the Academic Year, 2016-17, on Medical Grounds.

2. The Registrar, JNTUH, Hyderabad which is the University that has affiliated Guru Nanak Institutions Technical Campus, Ibrahimpatnam, R.R.Dist. has stated that as per the regulations, the candidate has to study the following subjects on his own and if he fails in any of the subjects, those subjects have to be studied to meet the course structure requirement up to Ist Year of **B. Tech CSE of JNTUH R15** Regulations:

Even though the subjects were studied at the earlier Institution / University, he has to study them again as per the **JNTUH R15** Regulations to obtain the required credits. The candidate has to study and pass all theory and lab courses as per the **JNTUH R15** academic regulations and syllabus.

3. Both the Colleges have given NOCs and the proposed transfer is within the 1% ceiling limit.

4. As per G.O.Ms.No.122, Higher Education (EC.2) Department, dated 01-09-2005, Condition 4 (4) reads as follows:

"no transfers can be permitted from one University affiliated private college to another University affiliated private college as all the Universities in the State are not following uniform syllabus and uniform system of examination"

5. The Government, after careful examination of the matter and in relaxation of the conditions in para 4 (4) of the G.O 1<sup>st</sup> read above, hereby accord permission for transfer of Mr. Uppula Bharath, B. Tech (CSE), II Year (provided he

is promoted to the 2nd Year) from Lovely Professional University, Punjab to Guru Nanak Institutions Technical Campus, Ibrhahimpatnam, R.R.Dist., (Affiliated to JNTUH) in the 2nd year in B. Tech (CSE) Course, on Medical Grounds, for the Academic Year, 2016-17, subject to the condition that the Four subjects mentioned in Para 2 above, the student has to study on his own to meet the syllabus course structure requirement upto the Ist year of B.Tech (CSE) of **JNTUH R15 Regulations and the transfer is to the Management Quota of Guru Nanak Institutions Technical Campus.**

6. The Director of Technical Education, Telangana State, Hyderabad / Secretary, Telangana State Council of Higher Education, Hyderabad / Registrar, Jawaharlal Nehru Technological University-Hyderabad, Hyderabad shall take necessary further action in the matter, accordingly.
