3. Both the Colleges have given NOCs and the proposed transfer is in the Unfilled Vacancy.

4. As per G.O.Ms.No.122, Higher Education (EC.2) Department, dated 01-09-2005, Para 4 (4) reads as follows:

"no transfers can be permitted from one University affiliated private college to another University affiliated private college as all the Universities in the State are not following uniform syllabus and uniform system of examination"

5. The Government, after careful examination of the matter and in relaxation of the conditions of Para 4 (4) of the G.O 1st read above, hereby accord permission for transfer of Mr. Vinay Gulani S/o Mr. Mukesh Gulani, Bachelor of Architecture, IIIrd year (provided he is promoted to the IIIrd Year) from R.V.College of Engineering, Bangalore to Sri Venkateshwara College of Architecture, Hyderabad in Bachelor of Architecture, IIIrd year, in the Unfilled Vacancy, for the Academic Year, 2016-17, on Medical Grounds, subject to the condition that he has to fulfill the Academic Regulations of JNAFAU, Hyderabad as mentioned at Para 2 above.
