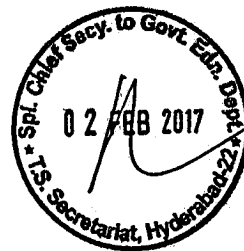

MINUTES OF THE VIDEO CONFERENCE ON TELANGANAKU HARITHA  
HARAM (THH) HELD BY THE CHIEF SECRETARY TO GOVERNMENT ON  
17.01.2017

\*\*\*\*\*

The salient features of the deliberations and decisions taken up during Video Conference by the Chief Secretary to Government with all the District Collectors and Forest Officers in the field on Telanganaku Haritha Haram on 17.01.2017 are as follows :-

- The Chief Secretary to Government in his opening remarks has once again reiterated that Telanganaku Haritha Haram is one of the most prestigious initiative of the Government and the District Collectors should closely monitor the programme in their districts.
- He has clearly emphasized that the most critical issue of the programme is the protection and survival of the plants planted. He has requested the district collectors to take up all possible measures to protect the plantations taken up during 2016-17 planting and ensure the survival during the critical months of April, May and June, 2017.
- He has also pointed out that the reporting system needs to be streamlined in order to get correct and uniform information from the districts. He has pointed out that as seen from the information furnished, the survival percentage in the districts having good rainfall and ideal conditions for plantations is shown as low as compared to other districts.
- He has emphasized that the District Collectors should find out the reasons for withering out of the plants and take all precautions and corrective measures in order to ensure better survival next time.
- He has requested the District Collectors to bestow their personal attention to the avenue plantations taken up in the districts and ensure the survival and protection of these plantations as these plantations form the most visible component of the programme.
- He has requested the District Collectors to review the level of preparedness of the district for launching 3<sup>rd</sup> phase of the programme during July, 2017 onwards and chalk out detailed planning for grounding 3<sup>rd</sup> phase of the programme in the districts.
- He has also requested the District Collectors to ensure timely payment under MGNREGS and emphasized that in no case the payments should be delayed beyond 15 days.
- He has informed the District Collectors that the senior level officers will be deputed from head quarter to randomly check the protection measures put at place and the survival of the plantations taken up in the districts under the programme.

- The Prl. Secretary to the Government, EFS&T dept., has reviewed the District wise progress of nurseries and other details and requested the District Collectors to check the information furnished by them before sending to the office of the Prl. Chief Conservator of Forests & HoFF, TS, Hyderabad.
- The Prl. Chief Conservator of Forests & HoFF, TS, Hyderabad has reiterated about rejuvenation of degraded natural forests and requested the District Collectors to involve the school children in the programme, in a big way to bring about awareness about forests, nature and environment as such among the children as they are the future of the country.
