The proforma of the consent to be obtained from the Heads of Institutions is enclosed. The details of the CC Cameras has desired in the said reference shall also be furnished.

In view of the above, while enclosing the letter under reference cited, the Principals of the Government/ Private Unaided Polytechnics are requested to furnish the details to CTE as desired in the proforma enclosed and forward copy to the exams@tspsc.gov.in, asexamstspsc@gmail.com, through E-Mail by 09.05.2017 and the copy of it may be sent to the respective collectors for further processing.

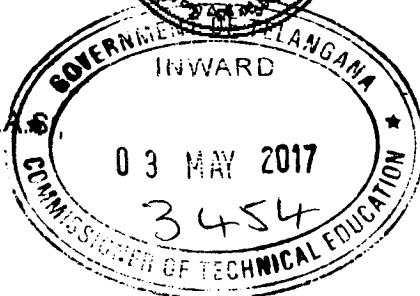

SUB: TSPSC - Examinations - Identification of educational institutions having good infrastructure and facilities including CC cameras in class rooms where candidates are accommodated to write the examination for conduct of written examination for various categories of posts of Residential Educational Societies scheduled to be held on 31/05/2017 and other TSPSC examinations in future - Request - Regarding.

Ref:- Govt. Memo. No.16987/Ser.A/A1/2015-1, dated:10/12/2015 from the Chief Secretary to the Government of Telangana State, Hyderabad.

I am to inform that the indents from various departments of Government are being received and the Commission have to fill up the posts by conducting written examinations in a transparent, secured manner to select meritorious and suitable candidates.

As the credibility of examinations of such a large scale will be at state and in view of the magnitude of the recruitments, the Commission is of the view to conduct the written examinations more smoothly and effectively and decided to monitor the conduct of examinations through CC cameras in the class rooms / examination halls. As TSPSC Command Centre will monitor from its Office, it is requested that such institutions having surveillance arrangements with internet connection facility only may be selected as examination Venues to the extent possible.

I am, therefore, to request you to kindly provide the list of suitable Government and Private Educational Institutions in your jurisdiction having CC cameras in the class rooms / examination halls, adequate security arrangements and good infrastructure like proper lighting, good furniture, drinking water, toilets, transport facility with easily accessible to the candidates from Bus stand / Railway station etc., for 500 and above candidates in each venue in advance as standard venues for TSPSC to conduct the written examination for various categories of posts of different Residential Educational Societies scheduled to be held on 31/05/2017 and also other examinations for various categories of posts by TSPSC in future. Out of the list, sufficient venues will be selected as per the requirement and necessity. The Proforma of consent to be obtained from the Heads of Educational Institutions is also enclosed.

You are requested that all the Chief Superintendents of selected venues pertaining to your department may also be instructed to extend their cooperation by furnishing the following information to the Commission's Office for making necessary arrangements to monitor the examination through CC cameras directly from the Command Centre of TSPSC.

In this connection, I am to inform that the institutions with high capacity of candidates will be preferred and the Commission's decision is final for selecting an Institution as examination venue & allotment of Candidates and appointment of Conducting Officers.

This may be treated as **IMPORTANT** and given **HIGH PRIORITY** as many items of work are linked to the above information as every care has to be taken in the selection of examination centre for conduct of recruitment examinations in a fair and smooth manner.
