The attention of the Principals of Govt. Polytechnics in T.S. is invited to the subject and ref.2<sup>nd</sup> cited, wherein it is stated that the proposal for renewal of Contract Lecturers and Contract Workshop Attendants is under the consideration of Government and the orders of the Government in the matter are awaited. Further, it is stated that issue of renewal by Government will be done in due course and that the renewal orders are valid for the entire A.Y. 2017-18. In the G.O. cited under reference (1), Government has permitted to engage the services of (435) Contract Lecturers and (160) Workshop Attendants on contract basis for the A.Y. 2016-17, subject to the condition that the renewal shall be strictly based on actual requirement with reference to the admissions and based on the similar conditions as stipulated in G.O.Rt. No. 136, Higher Education (TE) Department, dt. 26-06-2015 and subject to the following conditions:-

1. The Contract Lecturers / Workshop Attendants who are on rolls during A.Y. 2016-17 have to report on 08-06-2017 in the same station where they were working as on the last working day of A.Y. 2016-17.
2. The above orders are valid until the renewal process is completed for the A.Y. 2017-18.
3. The class-work shall commence for the 2<sup>nd</sup> and 3<sup>rd</sup> year from the first day itself i.e., w.e.f. 09-06-2017 and 1<sup>st</sup> year class work shall commence w.e.f. 14-06-2017 positively.

In the circumstances, while drawing the attention of the Principals / OSDs of the GPTs in T.S. to this Office Memo 3<sup>rd</sup> cited, wherein it had been instructed to terminate the services of the Contract Lecturers / Workshop Attendants from the Institutions where the Contract Agreement had been executed, even as some of them were deputed to the other Institutions on O.D. basis, it is now informed to utilise the services of such terminated Contract Lecturers in the parent Institutions (where the Contract Agreement had been executed Contractual salary drawn and subsequently services terminated) till the issue of further instructions in the matter. The Contract Agreement for the A.Y. 2017-18 shall wait till the receipt of the renewal orders of the Government. Further, it is hereby instructed to submit compliance in the format appended herewith on or before 10-06-2017 by email and in hard copy.

The receipt of the memo shall be acknowledged.
