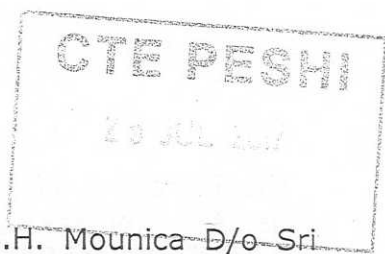

ORDER:

The Commissioner of Technical Education, Telangana State, Hyderabad in her letter 2nd read above has submitted that Ms. S.H. Mounica D/o Sri S.Harinath has requested for transfer from Sri Padmavathi School of Pharmacy, Affiliated to JNTU, Ananthapur, Andhra Pradesh to CMR College of Pharmacy, Kandlakoya, Medchal, Affiliated to JNTUH, Hyderabad in the Vth Year, Pharm.D for the Academic Year, 2017-18 on medical grounds.

2. The Registrar, Jawaharlal Nehru Technological University, Hyderabad which is the University that has affiliated CMR College of Pharmacy, Kandlakoya, Medchal has submitted the equivalence of the subjects upto IVth Year of Pharm.D Course and the subjects as per JNTUH R13 along with practicals equivalent to the subjects passed at Sri Padmavathi School of Pharmacy, JNTU, Ananthapuram.

3. Both the Colleges have given NOCs and the proposed transfer is within 1% ceiling of Management Quota.

4. As per G.O.Ms.No.122, Higher Education (EC.2) Department, dated 01-09-2005, Para 4 (4) reads as follows:

"no transfers can be permitted from one University affiliated private college to another University affiliated private college as all the Universities in the State are not following uniform syllabus and uniform system of examination"

5. The Government, after careful examination of the matter and in relaxation of the conditions in para 4 (4) of the G.O 1st read above, hereby accord permission for transfer of Ms. S.H. Mounica D/o Sri S.Harinath, Pharm.D, Vth Year (provided she is promoted to the Vth Year) from Sri Padmavathi School of Pharmacy, Affiliated to JNTU, Ananthapur, Andhra Pradesh to CMR College of Pharmacy, Kandlakoya, Medchal, Affiliated to JNTUH, Hyderabad in Vth Year, Pharm.D for the Academic Year, 2017-18, on medical grounds, subject to the condition that she has to fulfill the Academic Regulations of JNTUH, Hyderabad.

6. The Commissioner of Technical Education, Telangana State, Hyderabad / Secretary, Telangana State Council of Higher Education, Hyderabad / Registrar, Jawaharlal Nehru Technological University, Hyderabad shall take necessary further action in the matter, accordingly.
