ORDER:

The Commissioner of Technical Education, Telangana State, Hyderabad in her letter 2<sup>nd</sup> read above has submitted that Ms. S.Prathyusha Reddy D/o Sri S.Venkat Reddy has requested to transfer from Sri Devi Womens Engineering College, Affiliated to JNTU, Hyderabad to VNR Vignana Jyothi Institute of Engineering & Technology, Autonomous and Affiliated to JNTU, Hyderabad in the IInd Year, B.Tech (CSE) for the Academic Year, 2017-18, medical grounds.

2. The Registrar, Jawaharlal Nehru Technological University, Hyderabad, which is the University that has affiliated VNR Vignana Jyothi Institute of Engineering & Technology has furnished the equivalency of subjects studied by the student and he has stated that the candidate has to study the following subjects to meet the course structure requirement up to I Year, I & II Semester of B.Tech (CSE) as per VNR VJIET R16 Regulations:-

**\*The student has not studied the JNTUH R16 Syllabus of IT Workshop and the student has to study both the labs of IT Workshop and Engineering Workshop under one laboratory course at VNR VJIET. After completion of the IT Workshop the student will acquire 2 credits.**

Even though the subjects were studied at the earlier Institution, she has to study them again if failed, or not studied and which are not equivalent as per the VNR VJIET R 16 Regulations, to obtain the required credits. The candidate has to study and pass all theory and lab courses as per VNR VJIET R 16 Academic Regulations and syllabus.

3. Both the Colleges have given NOCs and the proposed transfer is within 1% ceiling of Convener Quota.

4. As per G.O.Ms.No.122, Higher Education (EC.2) Department, dated 01-09-2005, Para 4 (4) reads as follows:-

"no transfers can be permitted from one University affiliated private college to another University affiliated private college as all the Universities in the State are not following uniform syllabus and uniform system of examination"
