The attention of the Principals of Government Polytechnics is invited to the ref.1st cited, wherein the Contract Lecturers and Workshop Attendants who were on rolls / terminated at the respective Institutions during the A.Y. 2016-17 have been asked to report at the same Institutions on dt. 08-06-2017 i.e., the date of commencement of class-work for the A.Y. 2017-18, to utilise their services during the A.Y.2017-18 till the issue of renewal orders by the Government for smooth running of academic activity, as the proposal for renewal of the services of Contract Lecturers and Contract Workshop Attendants for the A.Y. 2017-18 was under the consideration of Government and the orders of the Government in the matter were awaited. Subsequently, in the G.O.3rd cited, the Government has accorded permission for renewal of the services of Contract Lecturers and Contract Workshop Attendants for the A.Y. 2017-18 and accordingly the renewal orders have been issued to Contract Lecturers and Contract Workshop Attendants for the A.Y. 2017-18, vide this Office Procs.4th cited. Meanwhile, the Government, in the G.O.2nd cited, has issued orders for enhancement of the remuneration of the Contract Lecturers working in Government Polytechnics in the State from @ Rs. 28,500/- (Rupees Twenty eight thousand and five hundred only) to Rs. 40,270/- (Rupees Forty thousand two hundred and seventy only) per month w.e.f. the Academic Year 2017-18.

In the circumstances, in the letter 5th cited, the Principal, Govt. Model Residential Polytechnic, Gajwel has sought necessary instructions for claim of difference of remuneration for the period 08-06-2017 to 09-08-2017 (i.e., till the appointment orders issued) for the Contract Lecturers. In this connection, it is to clarify that in view of the orders of the Government issued in G.O.2nd cited, for enhancement of the remuneration of the Contract Lecturers working in Government Polytechnics in the State from @ Rs. 28,500/- (Rupees Twenty eight thousand and five hundred only) to Rs. 40,270/- (Rupees Forty thousand two hundred and seventy only) per month w.e.f. the Academic Year 2017-18, the enhanced remuneration i.e., Rs. 40,270/- p.m. may be claimed for the entire period of the Academic Year 2017-18 i.e., from 08-06-2017 till the end of the Academic Year.
