ORDER:

In the Proceedings under reference 1st read above, Lecturers working in the Technical Education Department, Hyderabad were promoted as Senior Lecturers and posted in various Government Polytechnics.

2. In the reference 2nd and 3rd read above, Sri. K. Pulla Reddy, Lecturer in Chemistry, Lecturer in Chemistry, JNGP, Ramanthapur, Hyderabad and Sri D. Santosh Kumar, Lecturer in Chemistry, GPT, Masabtank, Hyderabad has been promoted as Senior Lecturers in Chemistry and Posted at Government Polytechnic, Gadwal and GPT, Nizamabad was relinquished Promotion to the post of Senior Lecturer in Chemistry in Zone – VI.

3. In the circumstances and under the provisions of Rule 10 (a) of Andhra Pradesh State and Subordinate Service Rules, 1996, Sri C. Radha Krishna, Lecturer in Chemistry, Q.Q. Government Polytechnic, Hyderabad whose name was approved by the DPC as "reserve" is temporarily promoted to the post of Senior Lecturer in the AICTE Scale of Pay of Rs. 15600-39100 with an AGP 7000/- and posted at Government Polytechnic Gadwal.

4. As per Rule 11 (b) of AP State and Subordinate service Rules, 1996 as amended in G.O.Ms.No.145 G.A (Ser.D) Dept, dt. 15.06.2014, he will be allowed 15 days of joining time from the date of receipt of the posting orders. If he fails to join the new post to which he is promoted within the said time limit or evade joining the post by proceeding on leave he will forfeit his right of promotion to the post for the present panel year. His case will be considered for promotion again in the next panel year, however subject to availability of vacancies.

5. The Principal, Q.Q. Government Polytechnic, Hyderabad is requested to relieve the above Officer immediately.
