**MINUTES OF MEETING HELD BETWEEN COMMISSIONER OF TECHNICAL EDUCATION, TELANGANA AND  
DIRECTOR, BOAT, CHENNAI ON INDUSTRY-INSTITUTION- INTERACTION IN THE CHAMBERS OF CTE AT  
11.00AM ON 12-03-2018.**

A meeting between the Commissioner of Technical Education, Telangana, Hyderabad and Director, BOAT, Chennai was held on 12-03-2018 at 11.00AM in the chamber of Commissioner of Technical Education, TS, Hyderabad.

The following Decisions were taken:

**I. Industry Institution Interaction:**

The Director, BOAT, Chennai invited the Commissioner of Technical Education to preside over the function to be conducted on Industry Institution Interaction to be organized with industries in collaboration with BOAT, Chennai at Dasapalla Hotel, Jubilee Hills, Hyderabad on 23-3-2018 from 6PM to 9PM.

**II. Apprenticeship Training :**

The Apprenticeship Training Programme was discussed at length:

It was observed that there is requirement of Diploma holders in industry, but due to lack of awareness of the scheme, the turn up for Apprenticeship Mela is poor in respect of Diploma holders even though no. of Placements are available. Hence, awareness program regarding Benefits of Apprenticeship Scheme and related Mela shall be conducted by all Polytechnics.

All the Polytechnics shall upload their institutions in the portal of BOAT, Chennai so as to facilitate the industry and students for selection.

The Director, BOAT, Chennai informed that there are (2) modes of Apprenticeship Training Programs. (i) Sandwich training program and (ii) Post Diploma Program. The sandwich Programme is for Bonafide Students of Polytechnic and the Post Diploma Programme for pass outs of Diploma.

The Director, BOAT requested that a nodal officer from each District may be nominated for coordinating with BOAT, Chennai, for causing Physical Inspecting of the industry which has applied for Registration. Hence the DRC Principals shall be nominated to coordinate with BOAT, Chennai so as to cause Physical inspection of the Industry whenever they called for.

The Director, BOAT informed that the industries from other States also may be informed to participate in the Apprenticeship Mela to be conducted in the state of Telangana. BOAT Chennai agreed to Coordinate the same.

**III. Industrial Training:**

A meeting with the Industries Department shall be conducted immediately so as to map the "Industry and Polytechnics" of each District for ensuing industrial training of Six months duration during the Academic Year 2018-19.

The Approval of AICTE, New Delhi shall be obtained for imparting (6) months Industrial Training as part of New Curriculum-18. For this purpose Senior Officers shall be deputed to AICTE, New Delhi.

A letter shall be addressed to BOAT, Chennai to correspond with MHRD to extend full cooperation in implementing (6) months duration Industrial Training proposed in the New Curriculum-18.

**IV. Career Guidance programme** Career Guidance programme shall be conducted in all Institutions from the Academic Year 2018-19 with the Collaboration of BOAT, Chennai. plan of Action shall be communicated to the Principals in consultation with BOAT, Chennai. The Expenditure details shall be worked out.
