ORDER:

In the G.O. third read above Guidelines were issued for transfer of employees working in Collegiate Education and Technical Education Department for the Year, 2018.

2. In the references 4th read above, the Telangana Govt. College Gazetted Teachers' Association & Telangana Gazetted Polytechnic All Lecturers' Association have requested the Government to consider those who have put in more than two(2) years service in a particular station as on 31.08.2018 instead of 31.05.2018 to be eligible to apply for transfer.

3. The Government after careful examination of the matter, have decided to amend the G.O. issued in the reference 3rd read above.

4. Accordingly, the following amendment is issued to G.O.Rt.No.115, Higher Education (TE) Department, dt:06.06.2018:-

In the Annexure to G.O.Rt.No.115, Higher Education (TE) Department, dt:06.06.2018, Para (4) (b) shall read as "those who have put in more than 2 years of service in a particular station as on **31.08.2018** shall be eligible to apply for transfer"

5. The Commissioner of Collegiate and Technical Education, Telangana State, Hyderabad, shall take further necessary action in the matter accordingly.
