Specific Guidelines on NDD to Education Department

Deworming of all eligible children (boys and girls) aged 1-19 at all Government /Government aided, Private & Private aided Schools and Junior Colleges on the 10th of August 2018 -National Deworming Day & Missed out children on the 17th of August 2018- Mop Up Day.

At the District Level:

1. A District Coordination Committee Meeting chaired by the District Magistrate to be attended by the District level officials of Health, Education and ICDS to prepare a District Action plan for implementation of the NDD in all the (31) Districts.
2. A District level Training conducted by the District Medical & Health Officer to be attended by the District Education Officers, District Intermediate Education Officers, Private School Association Presidents.
3. A PHC Level Training conducted by the Medical Officer to be attended by the Principals, Head Masters, Nodal teachers identified from each school and Junior Colleges as per the training Plan.
4. The NDD resource kit consisting of one banner, one poster, reporting formats and sufficient Albendazole tablets will be supplied by the District Health and Medical Officer to be made available at all the schools and junior colleges one week before the NDD.

At the School and Junior College Level:

- 1) The NDD resource kit to be collected by the Principal/ Head master from the ANM of the area in which the School /college is located.

- 2) Teachers & Lectures to inform parents about the benefits of deworming and Dates of NDD and MUD
- 3) Inform the children at the morning assembly and in the classroom about deworming and the benefits of having Albendazole Tablet on NDD.
- 4) Motivate all parents, relatives to get their children to school on NDD for deworming.
- 5) Share the messages at the School Management Committees and parent-teacher meetings
- 6) Inform parents, children, and community members about deworming messages appearing in newspapers, radio, and TV that they should watch/listen to carefully.
- 7) No drug administration will be done by the ANMs and ASHAs.
- 8) Only the teachers and lecturers must administer the tablets to the children.
- 9) Schools and Junior Colleges to Ensure safe drinking water is available.
- 10) Albendazole is a safe and easily chewable tablet
- 11) Do not instruct children to swallow the tablet without chewing it first.
- 12) Do not allow the child to take the tablet home.
- 13) Teachers must never give the tablet to children who are sick or are on any other medication -
- 14) Small children should be given half of a crushed tablet mixed in water. Crush the tablet between two spoons

- 15) The teachers must ensure that the child properly chews the tablet and drinks water.
 - 16) Still, if the child chokes on part of the tablet, make the child bend over on your lap and pat the child on the back till the tablet comes out
 - 17) Take the child to an open and shaded place and allow the child to lie down and rest
 - 18) If the child still does not feel well and in case of any adverse events to be immediately informed to the PHC Medical Officers and ANMs and call an ambulance.
 - 19) The 104 and 108 emergency helpline services are made available on NDD and MUD.
 - 20) Along with giving the tablet, the class teacher must ensure to mark a single tick (✓) next to each dewormed child's name in the class register and on mop-up day, mark a double tick (✓✓) next to the child's name
 - 21) Every teacher must count the number of ticks on the form after National Deworming Day and mop-up day separately and report this number to the headmaster
 - 22) The headmaster must ensure the accuracy of the reported date before filling it into the form. Seek help from teacher from the school for cross checking the calculations before submitting the form.
 - 23) After mop-up day, Principal or Headmaster should report all data in the School Reporting Form and submit to ANM by 22nd August 2018.
 - 24) A copy of the same to be retained at the schools and junior colleges for records.

- 25) Reporting formats should be filled by the teachers and lecturers as per the reporting cascade.
- 26) Monitoring visits must be undertaken by the state and district officials of education department to support and supervise on NDD and MUD. All the officials must ensure to fill the online monitoring check list forms during their visits.
- 27) For further reference the private school package, social media and Whats App messages uploaded in the NHM web portal to be effectively utilised by education department for increasing awareness on benefits of deworming.

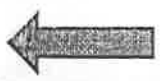
