**ORDER :-**

The Principal, Government Polytechnic, Bellampally in his letter vide reference read above, has submitted that, an amount of Rs. 1,00,00,000/- (Rupees One Crore only) was sanctioned by AICTE, New Delhi, the amount was also credited to Principal account on 28.06.2018 by way of online transfer for construction of Hostel Building for SC and ST students under the Government of India scheme at the institution. The Executive Engineer from TSEWIDC, Bellampally along with staff of from the Polytechnic have identified the place for construction of the Hostel Building. The building place and layout was also prepared by the Executive Engineer, TSEWIDC, Bellampally.

2. The AICTE, New Delhi has accorded sanction of the Council for an amount of Rs. 2,00,00,000/- (Rupees Two Crores only) and released amount of Rs. 1,00,00,000/- (Rupees One Crore only) being 1<sup>st</sup> instalment during the year 2017-18 under the SC/ST students Hostel Grant Scheme as Grant-in-Aid for meeting the expenditure for implementing the scheme at Government Polytechnic, Bellampally for the following conditions:-

1. The Minimum carpet area of the entire Hostel should not be less than 1040sqm.
2. Any expenditure incurred over and above Rs. 2.00 Crore grant to be released by AICTE shall have to be borne by the institute/State Govt. An undertaking to this effect must be submitted by the institute before utilization of the initial grant.
3. The institute shall maintain proper accounts of the expenditure out of the Grants which shall be utilized only on approved items of expenditure. The institute is required to open a separate Bank Account to get the interest on accumulation of the grant/fund received from AICTE.
4. The Grantee shall follow the terms and conditions of SC/ST students Hostel Grant Scheme as laid down by the Council from time to time.
5. Before utilization of the 1<sup>st</sup> instalment, the institute must ensure that all required undertakings/certificates including undertaking that no Hostel has been constructed under the funding of AICTE/MHRD, has been submitted.

2. After careful examination of the above proposal, Administrative Sanction is hereby accorded for the following works as shown below.

3. The above works are entrusted to TSEWIDC. Hence, the Managing Director, TSEWIDC, Hyderabad, is requested to take up the work to the extent of sanctioned amount and start the work at the earliest. The Hostel Building shall be so planned that total carpet area is 1024 Sqm. The design shall be made taking in to account existing facilities like Kitchen and dining. The designs of Hostel shall be submitted for approval of Commissioner of Technical Education, Telangana, Hyderabad before calling tenders.

4. The Managing Director, TSEWIDC, Hyderabad shall ensure that no work is left incomplete. No further amount will be sanctioned.

5. The Principal, Government Polytechnic, Bellampally shall release the amount to Executive Engineer concerned after receiving the work done and expenditure statement from the Executive Engineer concerned. He will also follow the conditions stipulated by AICTE in the matter.

**ORDER :-**

The Principal, Government Polytechnic, Nizamabad in his letter vide reference read above, has submitted that, an amount of Rs. 1,00,00,000/- (Rupees One Crore only) was sanctioned by AICTE, New Delhi, the amount was also credited to Principal account on 06.04.2018 by way of online transfer for construction of Hostel Building for SC and ST students under the Government of India scheme at the institution and also the amount of one Crore is credited into I.R.G Account of the institution. The Executive Engineer from TSEWIDC, Nizamabad along with Civil Engineering staff of from the Polytechnic has identified the place for construction of the Hostel Building. The building place and layout was also prepared by the Executive Engineer, TSEWIDC, Nizamabad.

2. The AICTE, New Delhi has accorded sanction of the Council for an amount of Rs. 2,00,00,000/- (Rupees Two Crores only)) and released amount of Rs. 1,00,00,000/- (Rupees One Crore only) being 1<sup>st</sup> instalment during the year 2017-18 under the SC/ST students Hostel Grant Scheme as Grant-in-Aid for meeting the expenditure for implementing the scheme at Government Polytechnic, Nizamabad for the following conditions:-
