ORDER:

Under the provisions of Rule 10 (a) of Telangana State and Subordinate Service Rules, 1996, the Junior Assistants working in Government Polytechnics/Institutions are temporarily promoted to the posts of Senior Assistant in the Scale of Pay of Rs 22460-66330 and posted at Government Polytechnics/Institutions as shown against their names in the Annexure.

2. As per Rule 11 (b) of TS.State and Subordinate Service Rules, 1996 and in G.O.Ms.No. 193 G.A. (Ser.D) Department, dt. 26.04.1999, they will be allowed 15 days of joining time from the date of receipt of the posting orders. If they fail to join the new post to which they are promoted within the said time limit or evade joining the post by proceeding on leave they will forfeit their right of promotion to the post for the present panel year. Their cases will be considered for promotion again in the next panel year however subject to availability of vacancies.

3. The promotions ordered above are purely temporary and liable for cancellation, at any time, without neither assigning any reasons there for nor do they confer any right or preferential treatment at the time of making their regular appointment to the posts.

4. The Principals of Government Polytechnics/Institutions concerned are requested to relieve the individuals concerned with instructions to report the new stations under intimation to this Office. The date of joining of the individual at their new stations may please be intimated.

5. The Promotions ordered above are subject the outcome from the TSTET/High Court/Supreme Court on the AO/W.P, SLP etc pending before them
