ORDER:

The Commissioner of Technical Education, Telangana State, Hyderabad in his letter read above has proposed for transfer of Mr. Dyapa Kowshik Reddy, B.E.(CSE), II<sup>nd</sup> Year from Gandhi Institute of Technology & Management, Rudraram, Patancheru, Hyderabad(Affiliated to Gitam Deemed University) to Chaitanya Bharathi Institute of Technology, Gandipet, Hyderabad(Autonomous & Affiliated to Osmania University), for the Academic Year, 2018-19, on medical grounds.
