Sub:- Academic-I – T.E. – Private Un-aided Polytechnics including II Shift Polytechnics in Engineering Colleges – Closure of Courses/Institutions during A.Y.2020-21 – Certain information – Reg.

Ref:- 1.Tentative Examinations Time Table Notified by the State Board of Technical Education & Training, Hyderabad
2.The Meeting held on "Perspective Planning of Technical Education – 2020 of Telangana State" on dt:27.01.2020

In the Ref.1st cited, the Secretary, State Board of Technical Education & Training (SBTET), Hyderabad has notified the Time Table of Diploma Examinations, which are scheduled to be completed well before April 2020.

The All India Council for Technical Education (AICTE), New Delhi will issue shortly Notification to all the existing Technical Institutions for giving option for closure of the Courses/Institutions for the Academic Year 2020-21.

In the Meeting 3rd cited, it has been noted that certain Private Un-aided Polytechnics including II Shift Polytechnics in Engineering Colleges have had poor admissions against the sanctioned intakes of certain Courses/Institutions as a whole, thus rendering them unviable to continue further during the forthcoming A.Y.2020-21.

In this connection, keeping in view the admission statistics of poor admissions against the sanctioned intakes of certain Courses/Institutions and trends for the last few years, such Private Un-aided Polytechnics including II Shift Polytechnics in Engineering Colleges are informed that they can apply for closure of the unviable Courses/Institutions during the forthcoming A.Y.2020-21, duly paying all the existing dues to the SBTET such as out-standing affiliation fees and then plan for the smooth transfer of the students on rolls to the other institutions as per the rules in vogue, well before commencement of A.Y.2020-21, latest by the end of March, 2020, so as to avoid hardship on account of unviable courses/Institutions in the changing scenario and thereby avoid inconvenience to the students and the administration by late applications for closure of unviable courses/Institutions. Further, at the level of the affiliating body, the Secretary, SBTET, Hyderabad is requested to issue detailed timelines in this regard, under intimation to this office.
