**ORDER:**

Under the provisions of Rule 10 (a) of Telangana State and Subordinate Service Rules, 1996, Sri. R.Shiva Lingam, Senior Instructor working in Government Polytechnic, Warangal, is temporarily promoted to the post of Workshop Foremen in the Scale of Pay of Rs. 29760-80930 and posted in the existing vacancy at Government Institute of Leather Technology, Hyderabad.
