The attention of the Registrars of the Universities in the State, as shown in the address entry, is invited to the Ref. 1st cited, wherein the Member Secretary, AICTE, New Delhi has issued Public Notice, inviting applications for approval of conducting Technical Programs / Courses for the Academic Year 2021-22 for the New / Existing Institutions. Further, in the Ref.3rd cited, the Pharmacy Council of India, New Delhi is also issued the Notification for Approval Process for the A.Y. 2021-22. Accordingly, various Technical Institutions (Engineering/ Pharmacy/ Architecture /MBA & MCA) in the State (both existing / new) are likely to apply for New Courses / Closure of Courses / Reduction or Increase in Intake etc.

In this connection, it is to inform that as a major stride towards total digitization of Higher Education Processes, Government of Telangana has initiated ICT intervention in Management of Universities, including University Online Affiliation System, a single window system designed to conserve time and infallible at all levels. The above portal encompasses various types of affiliations of existing Courses / New Courses / Closure of Courses / Reduction or Increase in Intake etc. and establishing new colleges, having provision for the colleges to upload data and documents on the Affiliation Portal and paves the way for affiliation / approvals by the respective Universities, Heads of the Departments and Government. This Online Affiliation System is expected to make Affiliation process simple and more transparent and will bring efficiency to the entire affiliation / approval process.

Therefore, the Registrars of the Universities in the State, as shown in the address entry are hereby informed to see that Technical Institutions (Engineering/ Pharmacy/ Architecture /MBA & MCA) in the State (both existing / new) shall make their applications in terms of the Notification issued by the AICTE / PCI, vide ref.1st & 3rd cited, through University Online Affiliation System through <http://ums.telangana.gov.in> with immediate effect.
