In response to this office communication under reference 3rd cited, two applications were received vide reference 4th to 5th cited.

2. After careful verification of the applications, it is noticed that the candidature of Smt. P. Karunasree , Sr. Instructor is not eligible for consideration for appointment by transfer as Librarian as she has pursued the M.Lisc from Allagappa University (Other State university) through distance mode and the same was rejected by this office earlier also. Hence, as per the judgment of the Hon'ble High Court in W.P.No.23237/2013 the same is not feasible for consideration.
