2. Meanwhile, this office has sent proposals to Government for renewal of the services of the above Contract and Outsourcing staff for the Academic Year 2021-22 vide reference 2nd cited and orders of the Government are awaited.

In the memo., 5th cited, Government have issued orders to conduct classes through online mode from 1st July, 2021 in the State duly limiting the attendance of teaching staff to 50% of total strength and certain instructions were issued vide reference 6th cited for conduct of academic instruction as per the academic calendar.

In the circumstances, in anticipation of the renewal orders of Government in respect of the services of the Contract Lecturers for the AY 2021-22 and to mitigate the hardship to them, permission is hereby accorded to the Principals/OSDs of Government Polytechnics to engage the Contract Lecturers and pay remuneration to the Contract Lecturers for the months of June and July, 2021 only, subject to the marking of bio-metric attendance and also other instructions issued vide reference 6th cited duly certifying the no. of days to be treated as "On Duty".
