- 1. Candidates who have passed Degree/Diploma in Engineering on or after September **2018,2019,2020 & 2021** in respective branches of Engineering can directly appear for the interview along with original certificates for verification (Returned immediately) /Xerox Copy of Provisional Certificate and 3 sets of BIO-DATA.
- 2. Students Participating in Apprenticeship Fair should enroll their name in the National Web Portal id :www.mhrdnats.gov.in to get User id & Password and bring the same during the Apprenticeship Fair.
- 3. Students should bring 4 sets of Xerox copy of User id mentioning Name, Branch and Year of Passing at the time of attending Apprenticeship Fair.
- 4. Candidates who have already undergone / undergoing apprenticeship Training are not eligible to attend the walk in interview.
- 5. Training period is ONE YEAR only under Apprenticeship Training Scheme of Board of Apprenticeship Training, (BOAT) Govt. of India.
- 6. Minimum Stipend prescribed during training: **Rs.9000/-p.m**. for Degree in Engineering, **Rs.8000/-p.m**. for Diploma holders in Engineering pass outs. Many Organizations including Government Organizations are paying more than the minimum prescribed.
- 7. No TA & DA payable for attending walk in interview.

- 9. If any branch of engineering for which the Industries are not participating, the bio-data of the candidate will be taken by our official to take further action to Place them as Apprentices under the Apprentices Act.
