ORDER:

Vide reference 1st read above, Vide reference 1st read above, the Minutes of the 17th Board Meeting held on 28.03.2022 from 3:00 PM at RUSA Resource Centre, Nampally, Hyderabad and communicated minutes of the meeting stating that (In accordance to Board Resolution No. 17-19/2022) the Board considered and approved to provide the Financial Assistance for the Financial Year 2022-23 Rs. 20.00 Lakhs (Rupees Twenty Lakhs only) to each Government Polytechnic towards up-gradation of labs and for development of infrastructure.

Further, the Secretary, SBTET, Telangana, Hyderabad, vide reference 2nd cited, has stated that earlier SBTET has released the amount from SBTET funds to the Govt. Polytechnics for procurement of lab equipments (2014-2018), Virtual classrooms product and up-gradation of labs on recoupable basis. After several reminders some Polytechnics have refunded the amounts and balance has to be recovered from the remaining institutions and requested to issue sanctions proceedings to Government Polytechnics after deducting lab equipment dues and virtual classrooms product due from Rs. 20.00 Lakhs.

This office has directed the Principals of Government Polytechnics to furnish requirement of Financial Assistance for Laboratory Equipment, Furniture and Civil Works for eligible amount, vide reference 3rd cited.

Further, the Principal, Govt. Polytechnic for Women, Pebbair has submitted proposal for Rs. 7,15,742/- for procurement of Laboratory Equipment, vide reference 4th read above.

The sanction is hereby accorded to the Principal, Govt. Polytechnic for Women, Pebbair for purchase of Laboratory Equipment of Rs. 7,15,742/- (Rupees Seven Lakhs Fifteen Thousand Seven Hundred and Forty Two only) as the approved rates & Agency communicated, vide reference 5th read above and meet the expenditure from SBTET Funds.

In view of the above, the Secretary, SBTET, Hyderabad is hereby directed to arrange to pay an amount of Rs. 7,15,742/- (Rupees Seven Lakhs Fifteen Thousand Seven Hundred and Forty Two only) to the Principal, Govt. Polytechnic for Women, Pebbair as Financial Assistance in Academic Year 2022-23 towards purchase of Laboratory Equipment.
