**ORDER:**

Vide reference 1<sup>st</sup> read above, the Minutes of the 17<sup>th</sup> Board Meeting held on 28.03.2022 from 3:00 PM at RUSA Resource Centre, Nampally, Hyderabad and communicated minutes of the meeting stating that (In accordance to Board Resolution No. 17-19/2022) the Board considered and approved to provide the Financial Assistance for the Financial Year 2022-23 Rs. 20.00 Lakhs (Rupees Twenty Lakhs only) to each Government Polytechnic towards up-gradation of labs and for development of infrastructure.

Further, the Secretary, SBTET, Telangana, Hyderabad, vide reference 2<sup>nd</sup> read above, has stated that earlier SBTET has released the amount from SBTET funds to the Govt. Polytechnics for procurement of lab equipments (2014-2018), Virtual classrooms product and up-gradation of labs on recoupable basis. After several reminders some Polytechnics have refunded the amounts and balance has to be recovered from the remaining institutions and requested to issue sanctions proceedings to Government Polytechnics after deducting lab equipment dues and virtual classrooms product due from Rs. 20.00 Lakhs.

This office has directed the Principals of Government Polytechnics to furnish requirement of Financial Assistance for Laboratory Equipment, Furniture and Civil Works for eligible amount, vide reference 3<sup>rd</sup> read above.

Further, the Principal (FAC)/OSD, Government Polytechnic, Vaddepally have submitted an estimates for Rs. 8,00,000/- (Rupees Eight Lakhs only) obtained from Deputy Executive Engineer, TSEWIDC, Wanaparthy for Extra facilities (Platforms and Shelves in Laboratories in First Floor) vide reference 4<sup>th</sup> read above.

The sanction is hereby accorded to the Principal (FAC)/OSD, Government Polytechnic, Vaddepally for Extra facilities (Platforms and Shelves in Laboratories in First Floor) of Rs. 8,00,000/- (Rupees Eight Lakhs only) and meet the expenditure from SBTET Funds.

In view of the above, the Secretary, SBTET, Hyderabad is hereby directed to arrange to pay an amount of Rs. 8,00,000/- (Rupees Eight Lakhs only) to the Principal (FAC)/OSD, Government Polytechnic, Vaddepally as Financial Assistance in Academic Year 2022-23 towards Maintenance and Repairs.

The above works are entrusted to TSEWIDC. Hence, the V.C & Managing Director, TSEWIDC, Hyderabad is requested to take up the work to the extent of sanctioned amount immediately and start the work at the earliest duly following the procedure. The Managing Director, TSEWIDC shall ensure that no work is left incomplete. No further amount will be sanctioned.

The Deputy Executive Engineer, TSEWIDC, Wanaparthy and the Principal (FAC)/OSD, Government Polytechnic, Vaddepally shall monitor the progress of works from time to time. The works shall commence strictly as per the rules under financial code/PWD code

The receipt of the proceedings shall be acknowledged.
